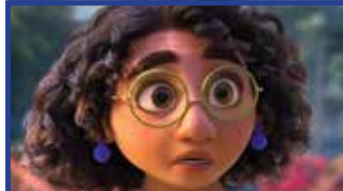

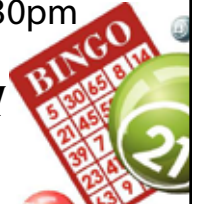

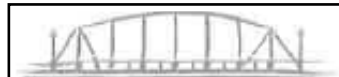

Mobile Opioid Treatment Offering Methadone Service in Sheridan

Great Circle Recovery's mobile clinic is an opioid treatment program that uses methadone and suboxone to help make recovery possible for those caught up in addiction to opioids.

The mobile unit, shown right, is clearly marked Grand Ronde Health and Wellness Mobile Clinic. It will be parked near the American Legion Hall on North Bridge Street in Sheridan between 11 a.m. and noon, Monday through Friday. No appointment is necessary.

Opioids are a class of drugs that include heroin, synthetic opioids such as fentanyl, and pain relievers manufactured legally and illegally such as OxyContin, Vicodin, codeine, morphine, and others.

Illicit drugs do not come with an ingredient list. Many contain deadly doses of fentanyl. Even in small amounts, it can be fatal.

Great Circle's Operation Director Jennifer Worth, MSW, warns that drugs taken in pill form can be just as dangerous as injected drugs.

According to the Oregon Health Authority, drug overdose deaths in Oregon more than doubled between 2019 and 2021, with the increase driven largely by misuse of the powerful synthetic opioid fentanyl. Preliminary data indicate that this trend has continued in 2022.

Over the last 30 months, fentanyl has become a leading cause of overdose deaths, particularly among people who don't have access to harm-reduction services.

In 2021, nearly a third of Oregon's counties saw more people die from fentanyl overdose than overdose from any other drug, OHA analysts found.

They warn that an overdose is always a medical emergency and individuals involved should call 911 immediately.

Addicts who visit the mobile unit in Sheridan will check-in upon arrival and have their vital signs taken. Then, they will face an intake process before moving on to the mobile unit's medical dispensary. Jennifer said the dispensary is behind a very thick door and is very safe, with cameras installed to see all areas.

The unit has window and glass-breaking sensors to help make it completely secure for traveling with methadone.

A finger scan and computer photo identify the patient and provide the prescribed dose for that individual. Then, a pump

dispenses the proper amount, and the individual is given the medication in a paper cup to drink and returns the empty cup to the staff.

Methadone works by reducing the craving for opioids.

Jennifer explained, "With fentanyl and heroin, the opioids are so powerful that addicts just seek that drug all the time. They'll do anything for it. Over time, the therapeutic dose of methadone gets them onto a dose that helps them not think about heroin or fentanyl 24/7. It helps that part of their brain a little bit to where they may start thinking about filling out a job application because they're not feeling sick anymore." Jennifer added, "When they don't have the opioids they're addicted to, they're thrown into vicious bone-chilling withdrawals.

"They go back to seek the opioid because the first time they do it, they have such an awesome experience, which they will never get back again. It's a one-time awesome thing. Then they get into this cycle where when they don't have it, they go into withdrawals, and they have to get more and more. The methadone treatment breaks this cycle. So basically, we're stopping that need to go out and commit crimes, etc.," said Jennifer. Jennifer said some people think methadone is just replacing one drug with another. She added,

"Methadone saves lives, methadone prevents crime, methadone prevents overdoses."

Jennifer explained that methadone treatment periods and doses vary per individual need.

She said the most important thing to remember is, "Every addict deserves to be treated like a human being and to know that hope and recovery are possible and they are not just a throw-away person."

She said, "By the time they seek help from us, they've been treated pretty badly by the health system, hospitals, primary care doctors, almost everyone they come in contact with because they are kind of a pain when they are in their addiction. They're not easy to be around. So we try to give them a little dignity and respect so they can start getting better." Jennifer said methadone costs one cent per dose, and in the long run, it is a great asset for our communities."

OHA has issued the following warnings to those who use drugs:

- Unless a pharmacist directly hands you a prescription pill, assume it is counterfeit and contains fentanyl.
- Assume any pills obtained from social media, the internet or a friend are counterfeit and contain fentanyl.
- If you are using pills, don't use

alone and always have naloxone on hand and visible.

- Test your drugs with fentanyl test strips before you use them. Fentanyl test strips can often be accessed at local harm-reduction sites.

A review of State Unintentional Drug Overdose Reporting System (SUDORS) and Oregon death certificate data by analysts from OHA's Injury and Violence Prevention Section found that unintentional/undetermined drug overdose deaths increased from 496 in 2019 to 1,072 in 2021. The 2021 figure doesn't include all fourth-quarter overdose deaths, which are still being tallied and analyzed.

Unintentional/undetermined fentanyl overdose deaths jumped more than 600% between 2019 and 2021, from 71 to 509, respectively. Of unintentional/undetermined drug overdose deaths in 2021, 47.5% were due to fentanyl; in 2020, fentanyl caused 32.1% of overdose deaths; in 2019, the drug was responsible for 14.3% of overdoses.

Overall, unintentional/undetermined overdoses from opioids, including fentanyl and heroin, also rose sharply during that time, from 280 to 739 deaths – a 164% increase. Unintentional/undetermined stimulant – methamphetamine – overdoses were up two-fold, from 325 to 658 deaths from 2019 to 2021.

Sheridan and Grand Ronde Firefighters Work Together on 'Burn to Learn'

Thirty-six firefighters joined forces at 125 Morgan Street in Sheridan on Saturday, July 2, to further hone their skills. About half of the crew were from the Grand Ronde Fire District and a half from Sheridan, with a few from other locations, such as Division Chief Scott Law, from Mc-

Minnville.

The house was the property of the City of Sheridan. A recent inspection of the house revealed that it was no longer safe for occupation and the cost for repairs and improvements was more significant than the house's value. Sheridan Fire Chief Les Thomas rallied the crew in front of the house on Saturday morning to outline plans and procedures before firefighters began preparing for the fire.

Crew with more experience helped others learn, for example, by working together to cut holes in the roof, which is often required for ventilation purposes. Grand Ronde's Assistant Chief Damon Schulze said fire science is critical in reading every fire's expected behavior. The 'Burn to Learn' exercises allows these firefighters to see and understand the characteristics of smoke: volume, color, velocity, and density. Fire science is the study of all aspects of fire, from fire behavior to fire investigation. Many seek-



ing careers in firefighting, fire prevention, protection, or safety pursue degrees in fire science. Firefighters did their best to save the tall trees located extremely close to the front of the structure. Lower limbs were removed before the fire. Damon noted that it might take six months and an arborist to determine if the tree, located just a few feet from the front of the house, would survive the extreme heat of the fire. He thought the odds were about fifty-fifty that the City of

Sheridan would need to remove it for safety reasons.

Another goal facing the firefighters was to burn the structure in such a way that the front of the house (facing Morgan Street) would be the last part of the house to burn so that when it caught fire, it would fall inward over the remains of the back of the house.

City Manager Heidi Bell estimated that this 'Burn to Learn' saved the City of Sheridan at least \$40,000 in demolition expenses.

Owner of New Riverside Cafe Addresses Sheridan City Council

Barb Hofenbredl, the owner of the new Riverside Cafe, addressed the Sheridan City Council at its July 6 meeting regarding tables, chairs, and plants she placed in the Hebert Plaza, a City park located next to her restaurant.

Barb's crew was installing black wrought iron fencing with an archway about 12 feet away from the restaurant's wall facing the

park when Sheridan City Manager Heidi Bell instructed her to stop the installation and remove her personal property from the public park. An agreement was made to allow the tables, chairs, and plants to remain, at least temporarily.

Almost everyone who weighed in on the issue agrees that the additions to the plaza look amazing. The problem is that this property

is a public park managed by the City of Sheridan. No permissions for its use had been discussed or agreed upon prior to the additions.

Barb said the outpouring from the community via Facebook has been phenomenal. "They're excited; they love it," she said.

Barb continued, "I didn't tell anyone that I own the park. It's open to the public. Since the City hasn't done anything with the plaza park... I went to the City about two weeks ago to speak to the city manager and never got a phone call back. We're getting really close to opening, and everybody wanted to know if we would have outside seating. I told them, "Of course, we will."

"It's open to the public. We aren't stopping anybody. But the community really wants it. So, I was going to have some signs made up so people would be aware that there is outside seating for them and that the area is open to the public. They can bring their own food or come inside and take out what they order. The tables and seating are for everyone to enjoy, compliments of the Riverside Cafe."

Barb said all are welcome to pick up food from IGA or Subway and enjoy it in the park.

"I want to put more picnic tables out there on the other side, too. I want to bring the people in the community out, so they feel safe to bring their kids, walk their dogs, so it's a friendly atmosphere, so everybody isn't saying, 'Oh my God, the only people here are homeless,'" said Barb.

Barb said that for the six months she'd owned the restaurant building, she has cleaned up the garbage every day, swept the sidewalks and street in front of the cafe, and kept it clean.

Mayor Rich Cox asked about the Parks and Recreation Committee working on park plans. Heidi explained that the Rotary Club, as a whole, is one member of the City's Parks and Rec Committee. A Rotary subcommittee with approximately 15 members has adopted the Hebert Plaza and the adjoining Morgan Street and Chester Moore parks on the riverfront. This group has been meeting every other week for the past few months. The last meeting was held at the Hebert Plaza and included a brainstorming walk around all three parks.

One of the subcommittee's first projects focused on the clock kiosk. Thanks to Terry Chrisman, the clock is sporting beautiful

new paint with colors voted on by committee members. The lighting above the clock was replaced, and the clock mechanism was repaired. So after several years, it is operational again. (Currently, a new, larger, easier-to-see clock face is in the works.)

After the subcommittee conferred with other groups and made a presentation to the City Council, an art deco theme that would compliment Sheridan's art deco bridge was given a nod of approval.

The committee's long-term plans for the plaza include enlarging the deck area to the west and removing the west wall to create ramp access to Morgan Street Park. These changes would create an outdoor stage area for music and performances with plenty of seating below in Morgan Street Park's grassy area.

The future of the privately-owned property to the north of the plaza, 106 S. Bridge Street (old Masonic Lodge), is still uncertain.

Smaller plaza projects currently being addressed include lighting, cameras, new flower boxes, tables, and benches.

Following Barb's comments at the Council meeting, Mayor Rich Cox told her he would meet with her within two days. He wanted the chance to talk with the City's attorney and the City's Parks Committee to find common ground to make this situation work for everyone.

Barb said, "The community is going to be very disappointed; they're going to be mad if I have to take it down. It's all over Facebook now because somebody started talking about it."

The mayor responded, "We don't want to run Sheridan by Facebook." Barb agreed.

Barb concluded, "The reason I'm here tonight is that I want a positive outcome, not a negative one for the community."

City Attorney Walt Gowell addressed the mayor, saying, "Typically, the Council, if they are inclined to allow private use of public property, would require a license agreement as a formalized permission slip that would need to be approved by the Council. It would set the parameters, be specific regarding what will be permitted, and typically requires insurance coverage."

Barb said she has a \$2 million insurance policy and would be happy to make some type of agreement with the City.

A MESSAGE FROM THE WILLAMINA SCHOOL DISTRICT

I hope this message finds all of you well and enjoying a memory-making summer! While summer break allows for much of our staff to reset before the start of a new school year, it is also a time of planning and preparation prior to the return of students.

At our July board meeting we approved the 2022-23 budget, composed of local, state and federal revenue. In addition to these funds the Willamina School District has been fortunate enough to be blessed with several competitive grants.

The PEEK-8 grant is a physical education (PE) expansion grant that supports the implementation of the k-8 PE requirements. The district receives nearly \$100,000 to fund two full-time PE teachers assigned to provide 150 minutes of PE per week, to students in grades k-5, and 225 minutes per week to students in grades 6-8.

The Yamhill County Care Organization (YCCO) grant supports a wide variety of programs aimed at improving student wellness and parent engagement. These funds are dedicated to funding staff and curriculum focused on social and emotional learning efforts, parent engagement events, suicide prevention efforts, and other similar program.

We are very excited about a new grant from the Willamette Workforce Partnership. This grant will fund a commercial drivers license preparation program. The funds will support the purchase of DMV approved curriculum and a commercial type vehicle for students to practice driving. In addition to licensing the students will receive training in diesel engine maintenance. In addition to our 17 and 18 years old students, this program will be offered to a select group of qualifying community members.

The Elementary and Secondary School Emergency Relief Fund III, awarded to school districts during the pandemic, are one-time funds with a variety of allowable uses. Willamina School District was awarded \$1.5 million in funding. 20% of funds must be used for unfinished learning and the other 80% can be used for projects that improve student learning, safety, health, and programs. Space on our campus has been our biggest deficit for many years now. For this reason we are using the funding to add six much needed classrooms, two restrooms, and office space. The addition will expand our current middle school building from six classrooms to 12. We hope to break ground soon and put the classrooms to use by fall of the 2023-24 school year.

RIVERSIDE CAFE IS OPEN: A local couple enjoy the sun and a hearty breakfast on opening day at Riverside Cafe last Monday. Cafe cooks and waitstaff were operating at high speed most of the day. The community has been eagerly anticipating the restaurant's opening.

Barb asked if she could leave the tables in place for now while things are being worked out.

The city manager requested the Council set out clear expectations for Barb so she could know what the Council wants at this point. In addition, she asked the Council to keep in mind the plaza group who've been meeting together. "They have a vision, too," Heidi added.

With the cafe opening on Monday, Barb needed answers to whether or not she could leave the tables in place.

The Council decided to give the cafe a limited two-week period to leave the tables in place while further research and discussion occur.

The goal is to find a compromise that benefits the community while protecting community assets. The Riverside Cafe opened last Monday.

Vandals Hit Sheridan Park

The community's children again must deal with the aftermath of vandals at the Sheridan City Park.

"Technically there were no swings, just the metal frame, which was pulled out of the ground, apparently by a truck or similar means," City Manager Heidi Bell explained.

Anyone with information about this crime is asked to call the Yamhill County Sheriff's office at (503) 434-7506.

Luckily, the additional vandalism at the park was recorded on the park's new cameras which identified the youths involved.

With conflicting information regarding various sections of Sheridan's three riverfront parks, especially Chester Moore Park, members of the Rotary Club's Riverfront Parks Subcommittee believe a land survey is in order. Title searches on record with Yamhill County, may help find documentation that will set the records straight.

For example, the City of Sheridan may or may not have a 99-year lease on the Chester Moore Park property. The Rotary Club is said to have added the concrete staircase from the IGA parking lot to the grassy area below in the early 1990s. Who owns this staircase? Also, it is unclear how much Yamhill County, which owns and maintains the Sheridan bridge, is involved. A Yamhill County drain ditch located in the middle of

Chester Moore Park is said to be there with permission from someone? The IGA is said to own the sloping bank area from the store's parking lot down to where the park more or less levels out.

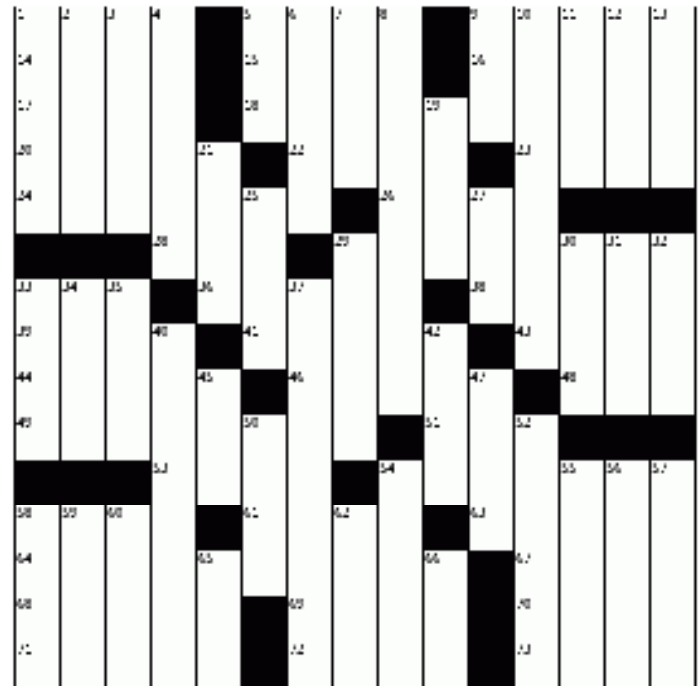
The City purchased the Morgan Street Park, (approximately one acre of land and a single family home), for \$33,467 in 1991. The original intent was to provide a public boat launch, public access to the South Yamhill River and parking for the downtown area.

However, it is unclear exactly where the property lines are for businesses with backs that border the park.

Knowing who owns or controls all facets of these properties seems necessary before any significant changes should happen in these areas.
